Dear Rental Property Owner,

The City of West Peoria includes over 400 rental units, comprising one-fifth of our housing stock. As a rental property owner, you are aware of the special responsibilities that landlords hold in terms of ensuring the safety, health and welfare of rental residents. This is a responsibility of interest to the City of West Peoria. Proper maintenance and management of rental housing is also critical to maintaining neighborhood character and improving the quality of life for all West Peoria residents.

Thus, the City of West Peoria is requesting all owners of residential rental property to provide their contact information to City Hall. The purpose for this registration is to help ensure a safer rental housing stock, protect property values and improve the accountability of rental units. The policy requires registration of all rental properties in the City of West Peoria every two years. There is no fee required. This is a voluntary program, but depending on its success, City Council may look into making this a mandatory policy in the future.

Please see the registration form enclosed. You may mail, fax or drop off the form at City Hall. Again, there is no fee involved. We greatly appreciate your cooperation in this matter and we thank you for your assistance in making West Peoria a better place to live! Please feel free to call us with any questions.
